# About Our No-Cost Services

#### **INFORMATION & ADVICE**

Pro Seniors' statewide Legal Helpline offers Ohio residents aged 60 and over free access to legal information and advice to help resolve issues that threaten their well-being and financial security.

#### **REPRESENTATION BEYOND INFORMATION & ADVICE**

Our staff attorneys provide legal representation to older adults in Southwest Ohio. These services address complex legal issues rarely handled by private attorneys, including Medicare, Medicaid, Social Security, other public benefits, financial exploitation, consumer law, and housing. Representation may include negotiation or litigation. In addition, our Pension Project assists Ohioans of all ages in securing the retirement benefits they are entitled to receive.

#### REFERRAL

When a senior's legal issue cannot be fully resolved through the Legal Helpline or by our staff attorneys, Pro Seniors seeks to connect the client with a private attorney through our Helpline Referral Attorney Panel. In 2024 we referred 1,360 matters to panelists for legal assistance. Over half of these referrals were provided on a reduced-fee or pro bono basis. Referral panelists play a critical role in bridging the justice gap for older Ohioans.

Guided Through Grief Paula's Journey with Pro Seniors



After the loss of her husband, Paula found herself overwhelmed trying to navigate the complexities of widow's benefits, Social Security, and Medicaid. "I had always handled everything," Paula said, "but suddenly, I didn't even understand half of what was happening."

Desperate for help, she reached out to Pro Seniors. She was quickly scheduled for a call with a helpline attorney, who guided her step by step through the application process. "He told me exactly what to do," Paula recalled. "Without them, I don't know what I would've done."

Pro Seniors also supported Paula earlier, when her husband required long-term care. Facing unaffordable facility costs, she turned to them again for help exploring Medicaid eligibility.

"They were there when I needed them most," Paula says. "All you have to do is call. Tell them what you need—and they'll help you through it."



Tracy reached out to Pro Seniors on behalf of her mother, Lucille, a resident of a senior apartment complex. Lucille was experiencing repeated billing errors—her rent was misapplied, and she was even double billed.

Frustrated and unsure where to turn, Tracy connected with Pro Seniors, where a helpline attorney guided her through next steps. The helpline attorney encouraged Tracy to escalate the issue to the executive management for the apartments. Once Tracy contacted management, communication improved immediately, and real action began.

With continued support from the helpline attorney, who offered advice and key resources, Lucille's account was fully audited. The audit confirmed the billing errors which were corrected, finally bringing resolution and peace of mind.

## **Selecting Long-Term Care**

Our trained ombudsman staff assist individuals and families in evaluating long-term care options. They help identify care needs, and available local services and providers to meet those needs. 719 complaints investigated



## Complaint Investigation & Resolution

Pro Seniors investigates and works to resolve complaints regarding nursing homes, assisted living, home care and long-term care services. We also have a specifally trained ombudsman to assist individuals enrolled in MyCare Ohio, the state's managed Medicare and Medicaid plans.



The Ohio Senior Medicare Patrol (SMP) empowers older adults to prevent, detect, and report health care fraud, scams, and identity theft. Through a combination of staff and volunteers, SMP provides group education and outreach both virtually and in-person at various locations across Ohio. These include senior centers, retiree events, senior housing, and partner organizations.
